Conditional Use Request for a Church within the C-1 (Neighborhood Commercial District) - 121 2nd Avenue, N. E. - Tax Map C20, Parcel 56 - New Covenant Christian Church of Grady Co., Inc., Applicant – Mr. Chick, Inc., Owner. (Both the SWGRC and the Cairo Planning Commission had recommended approval of the conditional use request). HB57 Solar Power Free-Market Financing Act 2015. Energy Services Director Rod Prince briefed the Council on HB57 and stated that a policy would need to be put in place to govern the use of solar, along with rules and regulations. A draft was reviewed, with Mr. Prince explaining to the Council that the City would need to determine a cost for those customers that would like to connect to our system. After discussion, it was decided that a policy would be presented at the next meeting to be considered for adoption.

Resolution for Recognition of Georgia Cities Week. After review, motion to approve the resolution was made by Councilman Cloud, seconded by Councilman Douglas, and unanimously approved by all Council Members.

OTHER BUSINESS:

Reports:

1.) City Manager:

- The Library had requested funding.
- There was a pre-construction meeting for the Community Block Grant -8^{th} St. Sewer Rehab.
- Five solid waste proposals had been received.
- Department budget workshops were being held.
- Met with Community Services Director Mitchell and Georgia Safe Sidewalks. There were a total of 387 mild hazards and 302 severe hazards over a total of 4.9 miles of sidewalk. After discussion, motion was made by Councilman Douglas to do the entire project at a total cost of \$38,135.00. Motion was seconded by Councilman Cloud and passed by all Councilmembers. The work on the project would begin the week of April 27th.
