## REGULAR MEETING - CAIRO MAYOR & COUNCIL - MAY 13, 2013

The May 13, 2013 Regular Meeting was called to order at 6:00 p.m. in the Council Room at 101-B North Broad Street with Mayor Richard VanLandingham presiding. Present were Mayor Pro Tem Ernest W. **NEW BUSINESS:** 

**Request from Five Star Credit Union.** City Manager Addleton reported that the credit union had recently purchased property between 1<sup>st</sup> Ave., NE and Highway 84 East to build a new building. The survey showed that the eastern boundary bordered a 20' wide right-of-way currently owned by the City. They were requesting that the 20' strip be abandoned in lieu of a simple utility easement. City Manager Addleton noted that the City had gas and CNS infrastructure in the area, but there were no plans to utilize the right-of-way as a road. After discussion, Councilman Gilliard made motion to abandon the 20' strip and deed it to the two adjoining property owners while retaining it as a utility easement. Motion was seconded by Councilman Thornton and passed unanimously by all Council Members present. Attorney Lehman was to prepare the documents.

**Election of District 10 Officers for 2013-14.** After review, Councilman Cloud made motion to elect the officials as nominated and specifying Mr. Ed Bond as Third Vice President. Motion was seconded by Councilman Thornton and passed unanimously by all Council Members present.
